**PURPOSE OF THE APPLICATION:**

To alter the existing 2 ½-storey detached dwelling by constructing: a rear two-storey, a side and rear third-floor addition, to reconstruct the front porch stairs and to construct a new rear detached garage.

**REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:**

1. **Chapter 10.10.40.40.(2)(A), By-law 569-2013**  
Additions to the rear of a detached house erected before October 15, 1953, are permitted provided; the floor space index as enlarged does not exceed 0.69 times the area of the lot (240.50 m<sup>2</sup>).  
The altered detached house will have a floor space index equal to 0.85 times the area of the lot (296.88 m<sup>2</sup>).
2. **Chapter 10.5.60.50.(2)(B), By-law 569-2013**  
The maximum permitted total floor area of all ancillary buildings or structures on a lot is 40.0 m<sup>2</sup>.  
The new rear garage will have a total floor area of 62.37 m<sup>2</sup>.
3. **Chapter 10.5.50.10.(3)(A), By-law 569-2013**  
A lot with a residential building other than an apartment building, is required a minimum of 50% of the rear yard for soft landscaping (69.72 m<sup>2</sup>).  
In this case, 45.4% of the rear yard will be maintained as soft landscaping (63.27 m<sup>2</sup>).
1. **Section 6(3) Part VI 1(I), By-law 438-86**  
Additions to the rear of a detached house erected before October 15, 1953, are permitted provided; the residential gross floor area of as enlarged does not exceed 0.69 times the area of the lot (240.50 m<sup>2</sup>).  
The altered detached house will have a residential gross floor area equal to 0.85 times the area of the lot (296.88 m<sup>2</sup>).

## **THE COMMITTEE OF ADJUSTMENT & MINOR VARIANCES**

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- **Attending the Public Hearing.** Attendant Care Services can be made available with some advance notice.
- **Sending a letter by Mail, E-mail, or Fax.** Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal

- If you wish to appeal a Decision of the Committee to the Ontario Municipal Board, you must file your written request for a decision with the Deputy Secretary-Treasurer.
