PURPOSE OF THE APPLICATION:

To alter the existing 2 ½-storey townhouse/rowhouse by constructing: a rear third floor addition, a rear second-storey balcony, and to convert the dwelling into two residential units.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- Chapter 10.10.40.40.(1)(A), By-law 569-2013**
The maximum permitted floor space index is 0.6 times the area of the lot (83.67 m²).
The converted townhouse/rowhouse will have a floor space index equal to 1.23 times the area of the lot (172.42 m²).
- Chapter 10.10.40.10.(1)(A), By-law 569-2013**
The maximum permitted height of a building or structure is 10.0 m.
The converted townhouse/rowhouse will have a building height of 10.74 m.
- Chapter 10.10.40.10.(2)(B)(ii), By-law 569-2013**
The maximum permitted height of all side exterior main walls facing a side lot line is 7.5 m.
The height of the side exterior main walls facing a side lot line will be 10.2 m.
- Section 6(3) Part II 3.F, By-law 438-86**
The minimum required side lot line setback for a converted house is 0.45 m, where the side wall contains no openings.
The converted townhouse/rowhouse will be located 0.0 m from the east and west side lot line.
- Section 6(3) Part II 3(I), By-law 438-86**
The minimum required side lot line setback from the side wall of an adjacent building that does not contain any openings is 0.9 m.

The converted dwelling will be setback 0.0 m from the side wall of the west adjacent building at, 145 Harrison Street and 0.0 m from the side wall of the east adjacent building at, 141 Harrison Street which contains no openings.

3. Section 6(3) Part I 1, By-law 438-86

The maximum permitted residential gross floor area is 0.6 times the area of the lot (83.67 m²).

The converted townhouse/rowhouse will have a residential gross floor area equal to 1.23 times the area of the lot (172.42 m²).

4. Section 6(3) Part II 5(I), By-law 438-86

The maximum permitted building depth is 14.0 m.

The converted townhouse/rowhouse will have a building depth of 17.47 m.

5. Section 4(2), By-law 438-86

The maximum permitted building height is 10.0 m.

The height of the converted townhouse/rowhouse will be 10.74 m.

6. Section 6(1)(iii)A, By-law 438-86

Only one addition is permitted to be completed at the time of the conversion or thereafter.

In this case, two additions are being proposed.

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- **Attending the Public Hearing.** Attendant Care Services can be made available with some advance notice.
- **Sending a letter by Mail, E-mail, or Fax.** Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal
