PURPOSE OF THE APPLICATION:

To alter the one-storey detached dwelling by constructing a second-storey addition.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. Chapter 10.10.40.40.(1)(A), By-law 569-2013**
The maximum permitted floor space index is 0.6 times the area of the lot (193.91 m²).
The altered dwelling will have a floor space index equal to 0.94 times the area of the lot (305.50 m²), including the basement.
- 2. Chapter 10.5.40.60.(7), By-law 569-2013**
Roof eaves may project a maximum of 0.9 m provided, they are no closer than 0.3 m to a lot line.
The roof eaves will project a maximum of 0.42 m and will be located 0.0 m from the east side lot line.
- 1. Section 6(3) Part I 1, By-law 438-86**
The maximum permitted residential gross floor area is 0.6 times the area of the lot (193.91 m²).
The altered dwelling will have a residential gross floor area equal to 0.62 times the area of the lot (200.82 m²).
- 2. Section 6(3) Part II 3.B(I), By-law 438-86**
The minimum required side lot line setback for the portion of the dwelling not exceeding a depth of 17.0 m and where the side wall contains no openings is 0.45 m.
The altered dwelling will be located 0.42 m from the east side lot line, where the side wall contains no openings.
- 3. Section 6(3) Part II 3.B(II), By-law 438-86**
The minimum required side lot line setback for the portion of the dwelling exceeding a depth of 17.0 m is 7.5 m.

The 0.94 m portion of the dwelling exceeding a depth of 17.0 m will be located 2.55 m from the east side lot line and 3.45 m from the west side lot line, measured from the rear second-storey deck.

THE COMMITTEE OF ADJUSTMENT & MINOR VARIANCES

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- **Attending the Public Hearing.** Attendant Care Services can be made available with some advance notice.
- **Sending a letter by Mail, E-mail, or Fax.** Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal
