**PURPOSE OF THE APPLICATION:**

To alter the existing 2½-storey detached dwelling by constructing a rear two-storey addition, a third storey addition, and a new front porch.

**REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:**

- Chapter 10.10.40.10.(1)(A), By-law 569-2013**  
The maximum permitted building height is 10.0 m.  
The altered detached dwelling will have a height of 11.0 m.
- Chapter 10.10.40.10.(2)(A)(i) & (ii), By-law 569-2013**  
The maximum permitted height of all front and rear exterior main walls is 7.5 m.  
The height of the front and rear exterior main walls will be 10.3 m.
- Chapter 10.10.40.40.(1)(A), By-law 569-2013**  
The maximum permitted floor space index of a detached dwelling is 0.6 times the area of the lot (185.0 m<sup>2</sup>).  
The altered detached dwelling will have a floor space index equal to 0.85 times the area of the lot (261.0 m<sup>2</sup>).

**4. Chapter 10.5.50.10.(3)(A), By-law 569-2013**

A minimum of 50% (78.0 m<sup>2</sup>) of the rear yard must be maintained as soft landscaping.  
In this case, 30% (47.0 m<sup>2</sup>) of the rear yard will be maintained as soft landscaping.

**1. Section 4(2)(a), By-law 438-86**

The maximum permitted building height is 10.0 m.  
The altered detached dwelling will have a height of 11.0 m.

**2. Section 6(3) Part I 1, By-law 438-86**

The maximum permitted gross floor area of a detached dwelling is 0.6 times the area of the lot (185 m<sup>2</sup>).  
The altered detached dwelling will have a gross floor area equal to 0.85 times the area of the lot (261.2 m<sup>2</sup>).

**THE COMMITTEE OF ADJUSTMENT & MINOR VARIANCES**

The role of the Committee of Adjustment is to provide flexibility in dealing with minor adjustments to zoning by-law requirements. To approve such variances, the Committee must be satisfied that:

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

**MAKING YOUR VIEWS KNOWN**

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- **Attending the Public Hearing.** Attendant Care Services can be made available with some advance notice.
- **Sending a letter by Mail, E-mail, or Fax.** Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal
